

Release Waiver and Indemnification Agreement

The following Release Waiver and Indemnification Agreement must be submitted for each person attending Camp Lucy. Minors under the age of 18 must contain the full names of the minor and his/her parents or guardian. This Release Waiver and Indemnification, The Registration Form and the Rules and Policies Form must all be signed by each person attending and returned to TGFLC Camp Lucy, keeping a copy for your records.

ACKNOWLEDGMENT OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I understand that participation in the TGFLC Camp Lucy is not without risk, harm or damage to myself, my dog or my property. Although health and safety precautions will be taken, factors such as personalities of dogs, the level of dog handling experience of others, the various types of physical activities, and the unpredictable nature of animals pose certain levels of risk beyond the control of TGFLC Camp Lucy. TGFLC Camp Lucy does not assume responsibility for any aspect of the safety of human participants, dogs or property. My participation in camp is done voluntarily and in full recognition of the risks to me and my dog, which risks I agree to assume while attending the camp.

Therefore, in consideration of my participation in TGFLC Camp Lucy, and for other valuable consideration, the receipt of which is hereby acknowledged, I, the undersigned, individually and/or as parent or guardian of my minor child if applicable, hereby forever RELEASE, discharge and covenant to hold harmless and indemnify TGFLC Camp Lucy, its employees, officers, directors, agents, contractors, and volunteers from any and all actions, causes of action and claims for personal injury or property damage, regardless of cause, including negligence, on account of or in any way growing out of directly or indirectly, actions of myself, my dog or others participating in, conducting or being involved in any way with the TGFLC Camp Lucy program.

I hereby certify that the following statements are true and correct and that TGFLC Camp Lucy has relied upon the truthfulness of information I provided in order to allow myself and my dog(s) to participate in the camp program:

1. I am the parent/guardian of a child 14 years of age or older (if applicable).
2. I have been fully informed of all the TGFLC Camp Lucy Rules & Policies and I agree to follow all such rules at all times while participating in the TGFLC Camp Lucy activities.
3. I understand that control of my dog is, at all times, my sole responsibility.
4. I represent that there are no medical or physical conditions that would prevent me and/or my dog from participating in the camp activities. I certify that my dog is healthy and free from contagious disease.
5. I have kept a copy of this release for my records.
6. I understand that staff members of TGFLC Camp Lucy have absolute authority to handle any dog or human situation as they see advisable.
7. I understand that at any time inappropriate behavior by me or my dog gives the TGFLC Camp Lucy staff the right to dismiss my dog and me from the program without refund.

8. I agree to be responsible for any and all damage caused by me or my dog to Camp Robin Hood (the camp that TGFL Fund contracted with to hold the Camp Lucy event), lodging facilities or property or the property of others while at camp.

9. I understand that the use of the lake/waterfront is at my own risk.

I will additionally permit free use of my name and pictures in TGFL Camp Lucy related broadcasts, newsletters or promotional materials. This release and its contents shall be governed by the laws of the Commonwealth of New York.

I understand that by signing this document I certify that I have read and voluntarily signed this Waiver and Release of All Liability and Indemnification Agreement.
